Regulatory Status, EMEA

Each of the Ingredion EMEA Companies manufactures & supplies their food starch products in compliance with:

For Modified Starches;

- EU food additives regulation¹ and the associated specifications^{2 3} for modified starches,
- JECFA specifications for modified starches⁴

For Native & Physically Treated Starches;

- The Food Chemicals Codex (FCC) specifications for food starch unmodified⁵.

These criteria specify either the process chemicals or process treatments that can be applied to edible starch to make it suitable for use in food and its intended application.
